General Information:

- ➤ The organizers of the conference are the Warsaw Stock Exchange (WSE), the International Herald Tribune (IHT), and The Warsaw Voice (TWV).
- The Host and Main Partner of the conference is the Capital City of Warsaw. Mayor Hanna Gronkiewicz-Waltz will deliver the opening speech, while members of the City Administration will take part in panel discussions and presentations.
- ➤ Conference venue: WSE
- ➤ We have asked Deputy Prime Minister and Economy Minister Waldemar Pawlak to lend his name to the event.
- ➤ In addition to topics related to the financial market, this year's conference will tackle issues linked with Poland's overall economic performance compared with other economies in the region and elsewhere.
- ➤ The official language of the conference is English (with simultaneous Polish-to-English interpreting).
- ➤ We want the event to attract international and Polish financiers and economists, investors, brokers, analysts, business executives (including managers from stock exchange-listed companies and businesses planning to enter the trading floor), in addition to politicians and the media from both Poland and abroad.

- ➤ The Polish government will be represented by senior officials from the Ministries of the Economy, Treasury, Finance, and Regional Development.
- ➤ The conference will be accompanied by two special sections, one published by The Warsaw Voice and the other printed by the International Herald Tribune.
- The Warsaw Voice special section will feature all sponsors (sponsor packages enclosed).
- ➤ The International Herald Tribune special section will offer special discounts to the organizers, partners and sponsors of the conference, ranging from 30 to 50 percent off the regular price, depending on the sponsor package.
